## TERMS & CONDITIONS FOR THE KASPERSKY SAFE FAMILY & GAMERS CONTEST (The "Contest").

# 4.4. Contest Eligibilty

- 4.4.1. Participants who wish to enter the Contest must submit their particulars in the following manner:

  - Step 3 Sign up (for new player) / Log in (for returning player) to the game.
