

TERMS & CONDITIONS FOR THE KASPERSKY SAFE FAMILY & GAMERS PROMOTION (The “Promotion”).

IMPORTANT: PLEASE READ THESE TERMS AND CONDITIONS (“**TERMS AND CONDITIONS**”) BEFORE ENTERING THIS PROMOTION.
